

# Are there subsidies for energy storage projects in France





#### **Overview**

On 21 December 2023, the Commission approved with the decision SA.107352 a €1.3 billion French scheme to support non-fossil technologies to ensure electricity supply matches demand. The measure aims to promote the development of energy storage facilities, together with other non-fossil flexibility. How much money will the European Commission spend on energy projects?

January 11, 2024: The European Commission said on January 8 it had given the go-ahead to state aid plans worth a total of nearly €4 billion (\$4.4 billion) for batteries, raw materials and renewables projects in France and Germany.

Eco-responsible companies in France can benefit from several types of assistance to support their green initiatives. Funds are available for the installation of solar panels, allowing companies to produce their own renewable electricity and reduce their dependence on fossil fuels.

What subsidies are available for clean cars in France?

In France, subsidies are available for the purchase of clean vehicles, such as




the conversion premium and the ecological bonus. The conversion bonus encourages the replacement of old vehicles with more ecological models, with financial assistance according to the eligibility criteria.

How much will France Relance invest in the energy sector?

In addition, in October 2021, the authorities announced a new investment plan called "France 2030." The plan, worth EUR30 billion until 2027, would complement France Relance and especially target further investment in the energy sector (EUR8 billion).




