#### **Overview**

#### Will Capital Power Buy PJM?

The acquisition is expected to close in the third quarter of 2025. The acquisition will serve as Capital Power's "strategic entry" into the PJM territory, and will position the company as one of five North American independent power producers with over 10 GW of natural gas capacity.

Capital Power has announced the strategic acquisition of two flexible generation assets in the US for \$2.2bn: the 1,124MW Hummel station in Pennsylvania and the 1,023MW Rolling Hills plant in Ohio.

How will Capital Power benefit from a broader fleet?

Capital Power plans to leverage its deep knowledge and experience in plant operations and power trading and origination to commercially optimize these assets and help drive long-term value as part of its broader fleet.

Is Capital Power's financial performance better than expectations for the first quarter?

Based on preliminary information, Capital Power's business and financial performance for the quarter ended March 31, 2025, as measured by Adjusted EBITDA6 and AFFO6, has been modestly better than management's expectations for the first quarter and confirms expectations underlying the 2025 guidance released in January.






