Overview

How many external power supplies are there in the EU?

In 2020, 1.7 billion external power supplies (EPS) were in use in the EU27, of which 75% for residential use, on average 6.5 units per EU household. They converted 48 TWh/a of electricity from the 220V mains to the input needed by the powered products.

What does EC 2019/1782 mean for external power supplies?

The European Commission (EC) has now published its revised regulation for the efficiency of all external power supplies (PSUs). The new EC 2019/1782 regulation means that all PSUs sold into the EU after the 1 st of April 2020 must comply with the following requirements:.

Do external power supplies have a power efficiency mandate?

At a global level, mandates for power efficiency exist for most consumer electronics and home appliances. External power supplies have had regulations dating back to 2004, when the California Energy Commission created one of the first mandates for efficiency of external power supplies used to power appliances or consumer electronic devices.

Is there an energy label for external power supplies?

No, there is no Energy Labelling regulation for External Power Supplies. Does the Ecodesign regulation for External Power Supplies requires the 'Common Charger' for certain products?

Are external power supplies a legal requirement?

In 2020 it was finally scrapped and in its place the EU introduced the new Ecodesign 2019/1782 requirements for external power supplies, which is a legal requirement, not a voluntary one.



Are external power supplies efficient?

The efficiency of external power supplies (EPS) has been a concern of power supply manufacturers and OEM's since California mandated the first efficiency requirements in 2004.

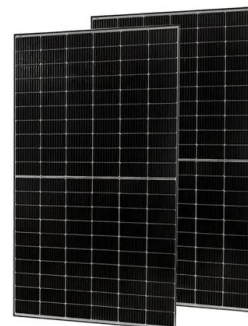

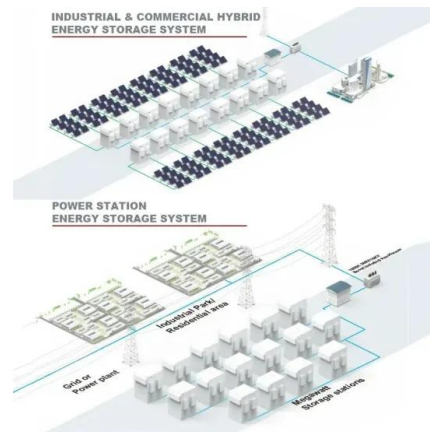
