International trade policies shape the global solar photovoltaic (PV) landscape through complex networks of tariffs, regulations, and bilateral agreements that significantly impact market dynamics and industry growth.

Will bifacial solar panels be exempt from tariffs?

The countervailing and anti-dumping duties are in response to a petition that a group of seven solar panel manufacturers called the American Alliance for Solar Manufacturing Trade Committee filed with the US government in April 2024.

Three recent events could impact the duties that U.S. companies will owe on imports from crystalline silicon photovoltaic ("CSPV") cells and modules. First, the U.S. Department of Commerce ("Commerce") initiated new antidumping and countervailing duty investigations on CSPV cells and modules from Cambodia, Malaysia, Thailand, and Vietnam.

What are the key compliance requirements for photovoltaic equipment?

Key compliance requirements typically include proper documentation of origin certificates, import/export licenses, and adherence to international quality standards such as ISO 9001 and IEC certifications specific to photovoltaic equipment.


