

How long is the warranty period for the energy storage charging pile of the energy storage cabinet





Overview

The standard warranty today is two years, both for performance and as a general product warranty. Most projects that are financed need a longer warranty. What are the different types of storage warranty?

In the energy storage sector, there are two main types of warranties: a product warranty, which is a guarantee against defects, and a performance warranty. In this context, we do not focus on the product warranty as much.

What do insurance companies look for in a storage company?

Insurers consider balance-sheet support and look for a developer to make a guarantee that is similar, if not stronger. In the context of energy storage, there are usually two types of warranties. First, there is a product warranty, which is a guarantee against defects.

How long does a lithium battery last?

Standard warranties for lithium-ion batteries cover both performance and defects for two years. Extended warranties can be purchased, but a warranty beyond 10 years does not make much sense because so much of the battery would need to be replaced after year 10. Insurance can also be purchased for longer coverage.

Does LG Chem offer an energy throughput warranty?

LG Chem offers an energy throughput warranty, meaning it warrants that the battery will deliver a certain amount of energy over a 10-year life. The number of times a day the battery is cycled affects the battery's lifespan, making energy throughput a crucial factor.

What happens if a battery storage system goes bankrupt?

If a battery storage system's managing company goes bankrupt, it would be challenging to replace the control software that ensures the system operates efficiently and provides savings for the customer. With battery storage, you



can have a system with 100% of year-one capacity, but if the software does not dispatch it correctly, it will not produce savings.

Are solar developers quoting energy storage in every deal?

Under Southern California Edison's GS3 time-of-use rate, energy storage is being quoted in every solar deal as the energy charge during peak periods, which are from 4 to 9 p.m. or 5 to 8 p.m., is as high as 40¢ a kilowatt hour. With the change in time-of-use rates in California, developers and solar installers are now quoting energy storage.

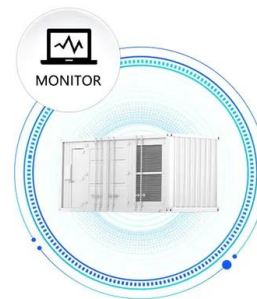

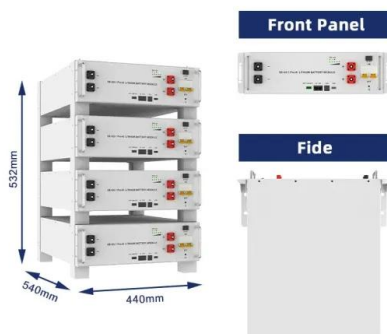
