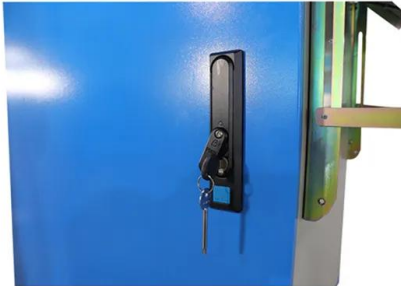


Why does Lesotho have a corporate tax rate?

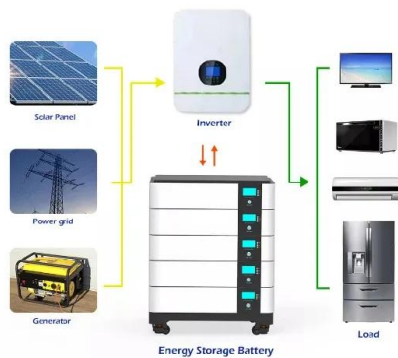

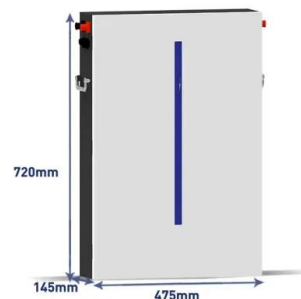

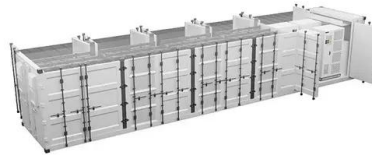
