Do I need to register my battery pack to get warranty service?

According to Milwaukee Tool, you do not need to register your battery pack in order to receive warranty service. However, Milwaukee uses the manufacturing date of the product to determine the warranty period if you cannot provide proof of purchase at the time you request warranty service.

What is the warranty period for a battery?

The following warranty periods apply specifically to the USA and Canada. The warranty period is 5 years / 2000 charges from the date of purchase, whichever first occurs. The first 1000 charges or 2 years of the warranty, whichever first occurs, are covered through free replacement of the defective battery.
