Who needs solar licensing information?

This comprehensive tool is designed for policymakers, stakeholders, practitioners, students, consumers, and anyone looking for solar licensing information in the United States. States establish licensing requirements for contractors to protect consumers from unsafe practices and to ensure systems are installed properly.

How many states have solar contractor licensing requirements?

Currently, 12 states and Puerto Rico have solar contractor licensing requirements. The contractor licensing requirements described here refer to solar-specific licensing requirements, rather than general electrical or plumbing contractor licenses.

Does a solar contractor need a license?

In states that do not require solar contractor licensing, certification can provide a baseline level of quality. State licensing may be restrictive, as state licenses do not typically transfer, so geographic mobility is limited.

Do I need a solar permit?

Solar permit requirements vary significantly by jurisdiction, but most installations require several key approvals to proceed legally. Most projects will require at least one of the following: Building permit: Required to verify structural integrity and ensure the installation complies with local building codes and zoning laws.

What is the National Solar licensing database?

With the tremendous growth of solar installations and the continuing evolution of licensing requirements for photovoltaic and solar installers, IREC's National Solar Licensing Database provides information and references to the licensing, certification, and other requirements impacting the solar industry.



Do I need a NABCEP certification to be a solar contractor?

In Utah and Rhode Island, NABCEP-certification is a prerequisite for qualifying for a state solar contractor license. In the absence of state licensing or certification requirements, local governments like counties or cities may adopt regulations or establish their own licensing procedure.


