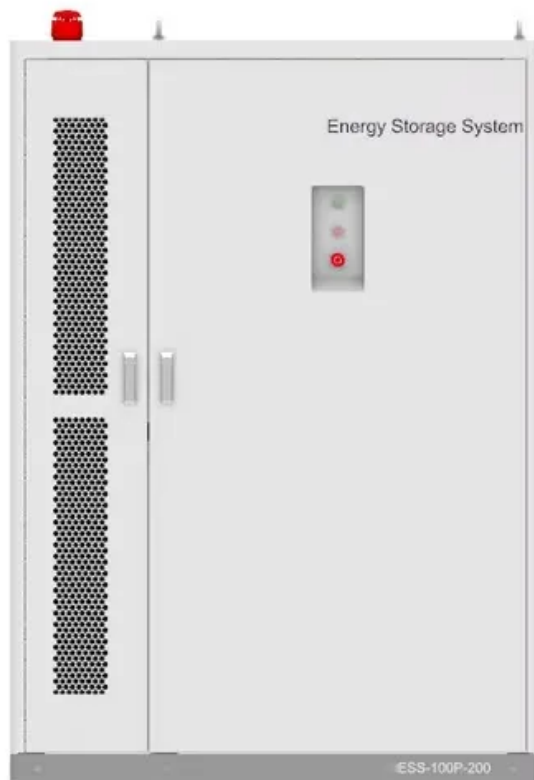


# **Tax-free export of photovoltaic modules**





## Overview

---

How does China's rebate rate affect photovoltaic exports?

This represents a 4% decrease in the rebate rate for photovoltaic exports, significantly impacting China's PV market, which heavily relies on exports.

What are export tax rebate mechanisms?

As an essential component of a country's tax system, export tax rebate mechanisms aim to balance domestic product tax burdens and allow domestic products to enter international markets at tax-free costs, thereby enhancing competitiveness and increasing exports. Key points regarding this change are summarized below:.

Will reducing tax rebates increase the price of overseas modules?

Zhang added that, in the short term, it will result in an increase in corporate costs, but in the long run, reducing the tax rebate rate is expected to boost the price of overseas modules.

What products will be canceled if my export tax refund is canceled?

Export tax refunds will be canceled for products such as aluminum, copper, and chemically modified animal, vegetable, or microbial oils and fats. Refer to Annex 1 for the detailed product list.
