

Taxation of bifacial solar panels





Overview

On June 21, 2024, President Biden issued Proclamation 10779, ending the exemption from Section 201 duties on bifacial solar panels imported on or after June 26 at 12:01 a.m. EDT. With the exemption removed, bifacial solar cells/panels will now be subject to Section 201 duties. Will bifacial solar panels be exempt from tariffs?

In his announcement, the President included an exemption for bifacial solar panels. This decision comes after the ITC recommended in November 2021 to extend the safeguard tariffs for an additional four years. Proclamations.

Are bifacial solar modules exempt from Section 201 tariffs?

WASHINGTON, D.C. — In a win for the solar industry, the U.S. Court of International Trade (CIT) re-instated the exclusion of bifacial solar modules from the Section 201 tariffs. Originally granted in June 2019, the exclusion for bifacial modules was revoked by the Trump Administration in October 2020.

Will bifacial solar cells/panels be subject to Section 201 duties?

With the exemption removed, bifacial solar cells/panels will now be subject to Section 201 duties. The affected solar cells and modules are classified under the following Harmonized Tariff Schedule (HTS) codes:.

What is a bifacial solar tariff?

This measure aims to support the announced 125 GW of solar module assembly manufacturing capacity without stifling emerging solar cell production. Bifacial solar panels, which are predominantly used in commercial, industrial, and utility-scale solar power projects, were previously exempt from tariffs.
