How much solar power does Vietnam have?

This included 16 billion kWh from solar power and 7.3 billion kWh from wind energy, according to data from Vietnam Electricity. Solar power, in particular, has seen significant expansion due to the implementation of feed-in tariffs and the increasing adoption of rooftop solar systems.

The Vietnam rooftop solar sector is set for a major investment boost with a new draft decree published in early October 2024.

On July 3, 2024, the government of Vietnam approved Decree No. 80/2024/ND-CP ("Decree 80") allowing large corporates to purchase electricity from renewable energy generators under direct power purchase agreements



(“DPPAs”).

Why has the Vietnamese government temporarily suspended solar projects?

To address the rapid growth and grid capacity issues, the Vietnamese government has temporarily suspended new approvals for large-scale solar projects. This measure aims to manage the grid’s ability to integrate new capacity and transition from the FiT scheme to an auction-based system for project approval and pricing.

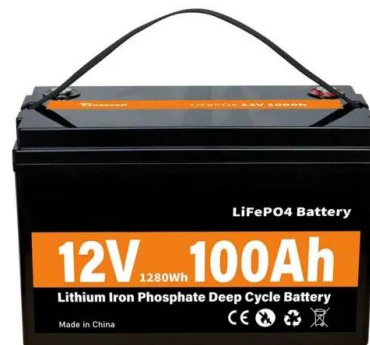

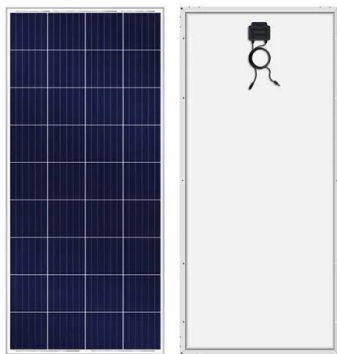
